

# WPPI Inspires 2020 Sweepstakes OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.**

**1) Eligibility:** The WPPI Inspires 2020 Sweepstakes (the "Sweepstakes") is offered to any individual who, pursuant to these Official Rules, provides a valid email address on [wppiexpo.com/contest](http://wppiexpo.com/contest).

No entry fee, payment, or proof of purchase is required. Employees, officers and directors, including members of their immediate families (parent, child, sibling, or spouse of each of the foregoing) and persons living in the same households as such individuals (whether such individuals are related or not) of Emerald X, LLC, 31910 Del Obispo, Suite 200, San Juan Capistrano, CA 92675 (the "Sponsor") or its affiliates or advertising and promotion agencies, are not eligible to enter. **3) How to Enter:**

**a. Provide your email address at the supplied point of entry at [wppiexpo.com/contest](http://wppiexpo.com/contest)**

**b. Free Method of Entry** During the Eligibility Period, enter your name, company, title, phone number, email address and age in the online form. For your entry received by Sponsor during the Eligibility Period, you will receive one entry into the Sweepstakes drawing.

**4) Weekly Drawing:**

Every week starting May 10, 2020 until June 21, 2020, the Sponsor will select one winner from among all registrants who registered during the Eligibility Period.

The Sponsor will attempt to notify the potential winner via email or telephone. If the potential winner cannot be contacted within two (2) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining eligible entries.
